The CEO will promote the organization to various government funding agencies and industries, and will represent the organization at all relevant meetings as deemed appropriate by the Board. The CEO is also responsible for communicating corporate objectives and strategies to stakeholders within Virginia Tech and outside the university community.

Candidates must demonstrate a distinguished record of accomplishments related to the acquisition of applied research and development programs, as well as research collaborations with government and private sector clients. Candidates must also demonstrate an understanding of research and intellectual property policies. Additional recommended qualifications include:

- Experience in strategic planning and execution in an early stage spin-out or subsidiary company environment.
- Knowledge of government contracting and experience in identifying revenue sources and marketing, acquiring and performing research contracts with federal funding agencies and private sector clients.
- Experience in reporting to a board of directors and working with such board to formulate policy and ensure appropriate corporate governance
- Experience in providing management oversight of international operations
- Ability to develop financial plans, analyze and interpret financial data, and manage resources in an entrepreneurial research environment.
- Strong communication, presentation and public relations skills.
- Demonstrated ability to communicate and interact with officials at all levels of government and with private sectors leaders and to work effectively with a wide range of constituencies in a

diverse community. Ability to motivate teams and simultaneously manage several projects managers.

- Demonstrated ability to promote the organization and be effective in a nonprofit research and university research environment.
- Qualified to obtain a DoD security clearance if required by specific contract(s).
- Willingness to work a flexible schedule and travel as required, including support offices in the Washington DC area and in Blacksburg, VA.
- Commitment to diversity in the workplace.
